**2023 Vegetative Environment Enhancement Projects
Neighborhood Community Cluster Project Photo Contest Rules**

DISTRICT: Commissioner District #: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, or 12

DIVISION: Neighborhood Community Cluster - entry to be of three or more individual resident's properties in the same Neighborhood Community entered as a cooperative entry, or to be of a common public property worked on by three or more people from different residents in the same Neighborhood Community entered as a cooperative entry.

SECTION: Personal, Familial, Communal, Educational, Spiritual, Commercial, or Governmental

CATEGORY: Landscape, Flower Bed, Container, Vegetable Garden

- 1) Only one entry, (including photos from at least three (3) participants) for one Category, per Entry Form, with 4" X 6" photo(s*) Attached. (*landscapes 3-5 photos from each project, all other categories single photo from each project)
- 2) Participant clusters may enter one entry in each of the various Categories.

- 7) The winner will be determined from all qualified entries
- 8) Awards will be cash incentives and/or gift cards redeemable toward the purchase of next season's plants/supplies. No additional purchase necessary. (Winners to be determined by Commissioner Distinct.)
- 9) **Photographs of 2023 Vegetative Environment Enhancement Projects will not be returned.**
- 10) Digital copies of winning photos may be requested for publication in media. All accepted photos may be used in various media formats for an unlimited amount of time and at no cost to the Alma Higgins Vegetative Environment Enhancement Program - Commemorative Competition, the Alma Higgins VEEP Photo Contest (The Contest) or the photo contest Facilitators / Sponsors / Supporters. Photo credit is not guaranteed for all uses of image.
- 11) By submitting an Entry Form with photos attached, an entrant acknowledges their agreement to all The Contest rules and restrictions, and gives permission to use entrant's *name* for promotional purposes by the Facilitators/Sponsors/Supporters.
- 12) Contest entrants further agree to abide by the decisions made by the judges. Judges' decisions are final.
